
Effect of Deep Water Horizon on BP share price






ESG Ratings Around The World

- The Machine learning methodology relies on algorithms that form part of the Python programming language.
- Algorithms are being used to follow a **structured** or **unstructured data** methodology depending on the data set from the data collating exercise.

Machine Learning methodology

- Key assumption: Data $(x_1, y_1), \dots, (x_n, y_n)$ are i.i.d random labelled examples with distribution \mathcal{D}_{ρ} .
- D_p is an unknown unstructured distribution e.g. Output of Bank financial statements data

<u>Input</u>

- Financial statements from Banks
- ESG reports from Banks
- Sustainability reports from banks


